

There are thousands of dog lovers in Texas, but Fred's big heart for canines is unique. You see, before he adopted Beau, he was savagely attacked twice by a neighbor's pit bull. The attacks were so traumatic that Fred needed surgery and came to both our team and attorney Scott Snellings for legal help. Still, he didn't want the pitbull put down — and continues to love dogs despite his trauma.

Fred babysits his neighbor's pooches, Bucky and Rowdy, and still misses Rocky, Bear, Buddy, and Beau every day. "In some cases, dogs are better than people," he says. His resilience is truly inspiring. Hopefully, if you're dealing with trauma, you can find the same strength.

## **DISTRACTED DRIVING WRECKS LIVES**

BLF Helped the Parks Find Peace After a Wreck

It only takes a second to read a text message — but that's all the time you need to miss the brake lights on the car in front of you and smash into their bumper. Recently, the Park family\* found this out the hard way.

The Park family was slowing down on a congested highway when the driver behind them glanced away from the road. His car barreled into their vehicle at 60 miles per hour. It crushed their trunk completely and seriously injured Mrs. Park, Mr. Park, and their two daughters, trapping them inside.

EMTs rushed the whole family to the hospital. Mrs. Park limped away from the wreck with severe back and knee pain. Mr. Park needed back surgery and, because of pandemic medical delays, will have knee trouble for the rest of his



life. Their daughters, Emma and Nicole, were also badly hurt. Emma's shoulder and foot pain still prevent her from doing the dishes at home, and she's terrified at the thought of getting her driver's license. Nicole, meanwhile, struggles to

focus on school months after suffering a concussion in the crash.

The Park family is still in bad shape, but their situation would have been worse if they hadn't found BLF! We told their story to the other driver's insurance company with enough conviction, compassion, and detail to secure them a settlement that changed their lives.

While no amount of settlement can give the Parks back what they lost in their health and wellness, it is helping them move forward as best as possible. qualified employees.
