Believe it or not, when I was little, I dreaded going back to school every August. Learning just wasn't easy for me. I struggled to read or write at my grade level, and taking standardized tests was a nightmare. Back then, no one would have guessed I'd become a lawyer. Only one person outside of my family believed in me: my fourth-grade teacher. Mrs. Howerton.

I can still picture this tall, imposing woman hunkered down with me at her kitchen table surrounded by assignments, firmly showing me the way.

 true happiness in life.
- Ms. Windlass taught Cristina high school math and also showed her that a classroom can be a safe space when an educator cares about her students as individuals.
- Jessica's third grade teacher, Mrs. Newkirk, helped her discover a passion for reading.
- Elizabeth's AP English teacher during her junior year of high school, Mrs.
 Hargis, went so far as to help Elizabeth with her college applications and write a recommendation letter for her.

A great teacher can do a lot of good in a child's life, like Mrs. Howerton did for me. But equally, a bad teacher or daycare provider can do a lot of harm. Far too many daycares today are understaffed or hire staff who are



unqualified, undertrained, or a bad fit for working with kids.

In one case we resolved, a child struggling to learn was transferred from one daycare to another and immediately became a straight-A student. It turns out a staff member at the previous daycare was an alcoholic with a criminal history and an aggressive streak. The kids were so terrified of this person that they dreaded going to daycare, couldn't focus, and struggled to complete their work. It was a really sad situation, and I'm glad we were able to step in to help.

No one wants their child in that environment. Every parent should have a daycare they can count on like the one my sister found for my niece, Aria. Everyone on staff there is well-trained, and they supervise the kids extensively to keep them safe. Thanks to their help, Aria is ahead of the game identifying words and shapes.

How We Secured a Full Policy Limits Settlement



When you're fighting a battle against injustice, you need all of the troops you can get. That idea was probably on attorney Slav's mind in 2020 when a gutwrenching trucking accident case came across his desk. Slav quickly picked up the phone and called in the troops: our team at The Button Law Firm.

The collision took the life of a man we'll call "Dave" — a loving husband and father

of three. Dave was hard at work loading vehicles onto a transportation truck when another driver swerved into the middle lane where he was parked. The driver collided with Dave and, although doctors fought to save his life, he passed away from his injuries.

The situation was truly tragic. Worse, it was preventable. The driver who hit Dave was an unqualified, untrained, and unsupervised employee driving a company car. They never should have been allowed behind the wheel.

As soon as our team heard the facts, we joined forces with Slav's Los Angeles-based firm (Abir Cohen Treyzon & Salo) to pursue a wrongful death case and secure compensation for Dave's family.

Of course, we knew that nothing could replace Dave's life: He'll never be able

to arm-wrestle with his son, walk his daughters down the aisle, or comfort his wife after a hard day again. In addition to that, Dave was also the main breadwinner for his wife and kids. His family needed money to pay his medical bills and move forward after the tragedy that tore them apart. So, we set out to get it for them.

Working with Slav and his team, we made a compelling case for Dave's family and what they were owed. Ultimately, we asked the insurance company of the unqualified driver's employer to settle for the full commercial policy limits and more.

Our hard work paid off. After a long fight, we settled Dave's case and secured the funds his family needed. That money will never fill the hole Dave's death left in their lives, but it will make things just a bit easier. As trucking accident and wrongful death attorneys, that's the most we can hope for.

PROTECT THE KIDS YOU LOVE FROM BOTTLE WARMER BURNS

At Home *and* at Daycare



Bottle warmers are great little devices: They can heat up breast milk or formula, warm jars of baby food, and even sanitize pacifiers. However, they're also one of the most dangerous pieces of equipment in daycare centers, and improper precautionary steps can put babies and toddlers at risk.

A bottle warmer that's left unattended or stored improperly is a nightmare waiting to happen. Our team regularly helps families with kids who have suffered bottle warmer burns at daycare. Recently, we represented the family of a young boy who was badly injured when a bottle warmer fell off the counter at his daycare and splashed boiling water on his face!

The little man was left with extremely painful second-degree burns — all because the staff his parents thought would protect him didn't do their jobs properly.

Something like that should never happen at a daycare facility. It's easy to childproof a bottle warmer, and it's required by state safety regulations. Daycare workers are required to make sure that bottle warmers are:

- Located on a counter
- Properly secured
- Free from dangling cords

In the best daycare facilities, bottle warmers are kept in a separate room that children can't access. You can use these same strategies if you have a bottle warmer at home. Unfortunately, too many daycare providers fail to follow these rules, either because they're understaffed or undertrained. Worse, occasionally daycare workers will use bottle warmers to intentionally abuse children.


