THE HIDDEN ABUSE IN 'TRANSPARENT' DAYCARES

BLF Stepped in When Livestream Cameras Failed to Protect a Child

If a daycare has a livestream camera that parents can access at any time, you might assume that it's a safe place to leave your children. After all, employees will stay on their best behavior when they're being recorded ... right? Unfortunately, that's not always the case. Even the most "transparent" daycares can still participate in negligence and abuse — and one Texas mom we represented found that out the hard way.

That mom, who we'll call Jessica, logged on to her son's daycare livestream and witnessed a caregiver mistreating him. The employee yanked her little boy by the arm, pushed his head down aggressively into his pillow, isolated him from the other kids, and even refused to give him food and water!

Jessica was shocked by what she saw, and her son (we'll call him Shilo) was



traumatized. She quickly called the daycare, and they admitted to the abuse – but they didn't report it to the state of Texas. Eventually, the Texas Health and Human Services Commission and the Texas Department of Family and Protective Services found out about the situation and discovered even more hidden misconduct.

That same caregiver let Shilo walk and sleep with a bottle in his mouth (both prohibited by the Texas minimum standards for child care), threatened him, and scared him so badly that he was caught on camera crying and running away in fear. The state quickly stepped in to ban the offending daycare employee and force the facility to fix its operations, but it was too late for Jessica and Shilo.

Jessica couldn't turn back the clock and keep her son safe, but she could hold the daycare accountable — so she turned to BLF for help. We went to bat for her and her son, laying out all of the daycare's violations and mistakes. Our effort paid off! We were able to secure a recovery for Shiloh so that this family could move forward and heal.
