The Fighter Who Taught Me 'Never Give Up'

When my Aunt Nancy Gavek found out she had Stage 4 pancreatic cancer, the doctors gave her three months to live. But Aunt Nancy was having none of it. She had too much family to love and too much to live for — so she decided to stick around.

Over the next two years, Aunt Nancy truly perplexed her doctors. She had a lot of ups and downs with her health but every time she went in for an appointment she seemed to be doing better than the time before. She fought off that nasty disease for as long as she could, and ultimately she won herself an extra year and nine months with her husband Donnie, their kids, and their grandkids.

7 LESSONS FROM 7 YEARS IN BUSINESS

Cheers to Beginning Year Number 8!

This January, BLF hit a major milestone: We've officially been in business for seven years! Can you believe it? When our anniversary arrived, I sat down to reflect on the journey and came up with seven lessons I've learned — one for each year. If you're an entrepreneur or manager, feel free to steal these takeaways for your team.

- Aim to set a personal record (PR) every day. The phrase "life is a marathon, not a sprint" is dead wrong in business. Each day of operating BLF has been a sprint to overcome the previous day's personal best. That mentality helps us stay focused and avoid complacency.
- 2. Treat every project as its own mountain. When we take on a new case, we don't assume our past experience has given us a leg up. We always start from the bottom. This allows us to continually adjust our systems and processes instead of getting stuck in the way we've always done things.
- Evolve every 18 months. BLF is constantly innovating and developing, but we hit a new phase of our evolution every 18 months. Going forward, I'll keep pushing for that timeline.

- 4. Autopsy everything. When an obstacle pops up, we always document how we overcame it and build out processes and systems based on what worked and what didn't. That helps us overcome future obstacles more quickly and efficiently.
- 5. Don't be afraid to reshuffle your team. It's a gamechanger to have all of your team members in the right seats, with responsibilities that reflect their strengths. Experimenting with this was key to our 18-month evolution.
- 6. Live by the 40% Rule. Retired Navy SEAL and Endurance Athlete David Goggins says when you feel like giving up, you're only giving 40% of your true potential. Living by this rule helps us tap into new reserves of strength during tough cases.
- Strive to be uncomfortable. The more you challenge yourself to succeed in unforgettable situations, the more you'll grow.

Ultimately, running a business is like climbing a mountain over and over again. Every time you reach the top, you discover you can push yourself farther. I can't wait to see what I learn in year eight.

HOLDING A DANGEROUS DAYCARE ACCOUNTABLE

BLF Secures Justice for an Injured Child

When daycares try to cover up the bad behavior of their staff, security cameras always tell the truth. That's exactly what happened in the case of our young client, Rex.

Rex's Sad Story

Rex woke up from his nap one day in pain. He refused to move his left arm. After his mom contacted our firm, we were able to get a hold of the security footage and see what happened to Rex. In an attempt to put him down for a nap, one of the daycare employees pinned him down on the bed, then yanked him hard by the arm. This wasn't a gentle pull — the caregiver *dislocated Rex's left elbow*!

Rex's mom pulled him out of that daycare, but he wasn't the same kid anymore. He hid his clothes and shoes to avoid his new daycare, and even resisted and fought with his mom when she tried to get him in the car. He had nightmares and angry outbursts. When we took his case and learned about the abuse, we knew that there must be more going on at that daycare. So, to get justice for Rex, we started to dig.

The Dangerous Daycare

Despite the fact that it had been open for less than a year, the daycare center had a long list of state citations and allegations from parents. According to those records, one employee had *literally washed a child's mouth out with soap*. Another had roughhoused with a child until they fell over and hit their head.

We used those past reports as leverage with the daycare's insurance company to resolve our client's case. Rex and his mom were able to use the settlement as closure on what happened and also know that no future kids would be harmed by this daycare provider.

Keeping Your Child Safe

Here at BLF, one of our missions is to close dangerous daycares like this one and ensure every child has a safe, nurturing experience.
