#### **Investigation Findings:**

Disposition (if A/N):

Explanation of Disposition:

Based on in the information obtained, a child did sustain a bump to the head; however there is no indication it was the result of lack of supervision. The child was interviewed and he said he was hit by his friend. No visible bump was observed during the interview. In regards to children going to the restroom unattended, a staff reported that she was told by the Director, Mrs. \_\_\_\_\_\_\_ that it was ok to send the children to the restroom in small groups without a teacher present. She said that the child was wearing a pull up and she was not aware of this so when she would send him to the restroom he had on a pull up. The pull up was soaked with urine and not changed because she was not aware he had one on and because she did not accompany the children to the restroom to know he had on a pull up. The children going to the restroom without a caregiver is a supervision deficiency.
