LEFT BEHIND HOW A HOUSTON DAYCARE FAILED A CHILD AND BETRAYED A FAMILY'S TRUST

One of the most basic promises a daycare makes to families is that their children will be safe. But for one Houston family, that promise was broken in a deeply alarming way when their 6-year-old son was left alone in a daycare van—and the daycare tried to cover it up.

A daycare employee failed to make sure this child got out of the van. The driver then parked the vehicle and left. Alone and confused, the child eventually realized no one was coming for him.

He managed to climb out of the van on his own and wandered into a busy shopping center parking lot next door. Thankfully, a Good Samaritan noticed him and kept the boy safe until the daycare owner finally arrived and identified him.

Even after this terrifying incident, the daycare's first response wasn't to tell the

truth. Instead, they told the child's parents he had been dropped off at school as planned. But that story quickly fell apart.

Once the parents discovered the truth, they contacted our team at The Button Law Firm.

What happened wasn't just a mistake—it was a severe failure that never should have occurred. Childcare centers are expected to keep accurate records, conduct name-to-face checks, and ensure every child is accounted for before leaving a vehicle.

None of that happened here.

The impact on this young boy has been heartbreaking. Since the incident, he has developed significant anxiety. He's afraid to be alone—even for a few moments. He began experiencing panic attacks and nightmares, often waking up crying after dreaming about a monster in the van.

The Button Law Firm worked closely with the family to help them navigate the emotional and legal aftermath of this incident.

Our mission has always been to stand up for children and hold negligent daycare centers accountable. While nothing can erase what happened, we're proud to have helped this family find the clarity, support, and peace of mind they deserved.

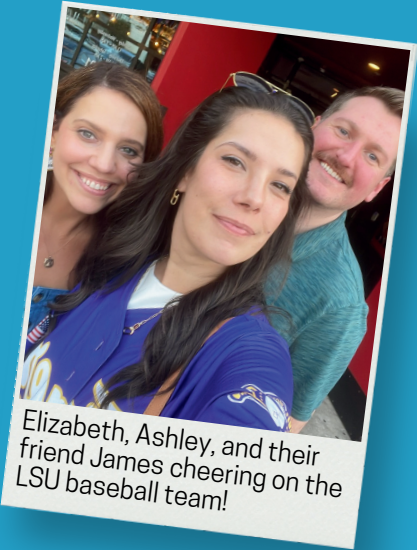

Cristina, your impact doesn’t go unnoticed - we’re proud of you and grateful for everything you bring to the team. Here’s to five amazing years and many more ahead!



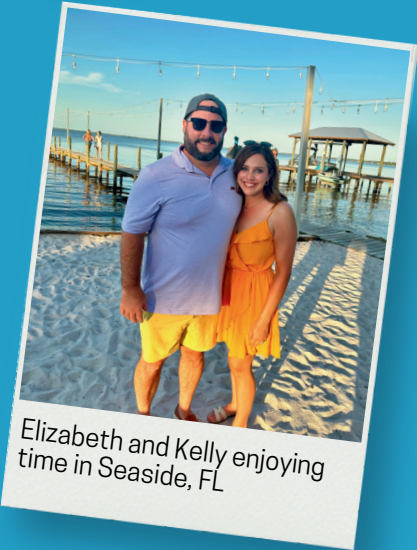
