### BELIEVING IN BETTER FOR DALLAS KIDS:

#### THE BLF TEAM VOLUNTEERED WITH THE COMMUNITY PARTNERS OF DALLAS

At The Button Law Firm, our work has always been about more than the cases we handle. We're driven by a bigger question: **how can we continue protecting children and supporting families even outside the courtroom?**

That question is what led us to Community Partners of Dallas (CPD). It started last summer, when we came across National Make a Difference to Children Month. The idea spoke to the heart of our mission.

That conversation sparked the idea of a back-to-school drive, but we wanted it to be more than a collection of supplies. We wanted to connect with a group that shared our passion for helping kids.

Their work to provide safety, dignity, and care for children in crisis aligned perfectly with our own belief that every child deserves to feel safe and supported. It felt like the right place for our donations, and the right partner for our team.

Visiting CPD made the connection even more real. What stood out most wasn't just what they do, but how much they care. Their Rainbow Room, a resource center stocked with essentials for children, carries only brand-new clothes, because kids in crisis deserve to receive something special that's theirs alone.

The bedrooms are decorated like small houses and designed to feel warm and child-friendly. Even the food choices, like chicken nuggets and mac and cheese, are intentional, offering comfort during a time when life may feel overwhelming.

These details reminded us of something we see often in our cases: it's the little things that can make the biggest difference in a child's healing.

When we volunteered during the back-to-school season, our team sorted backpacks so caseworkers could easily pick up what their kids needed. It may sound simple, but standing in a warehouse filled with rows of supplies ready to go into the hands of thousands of children was powerful.

We left with a deep appreciation not only for CPD's mission but also for what it meant for BLF to be part of it.

More than anything, the experience reaffirmed why we do what we do. Seeing another team so invested in children reminded us that protecting kids takes a community of lawyers, advocates, organizations, and neighbors working together.

As our marketing manager, Margo, reflected, "Being at CPD showed us that when people come together with the same passion for protecting children, real change happens. It reinforced why we do what we do at BLF."

For BLF, supporting CPD wasn't just about donating supplies. It was about living out our mission, connecting with people who share our values, and taking another step toward building a safer future for children in Dallas.

When a young woman was hit by a driver who ran a red light in Lake Worth, her life changed in an instant.

The crash spun her car across the intersection, leaving her dazed and severely injured. The situation worsened when the at-fault driver lied to the police at the scene while she was disoriented and unable to speak. Insurance companies relied on his story and denied her claim.

Our team secured video evidence proving the other driver ran the red light and worked closely with medical experts to document the full impact of her injuries.

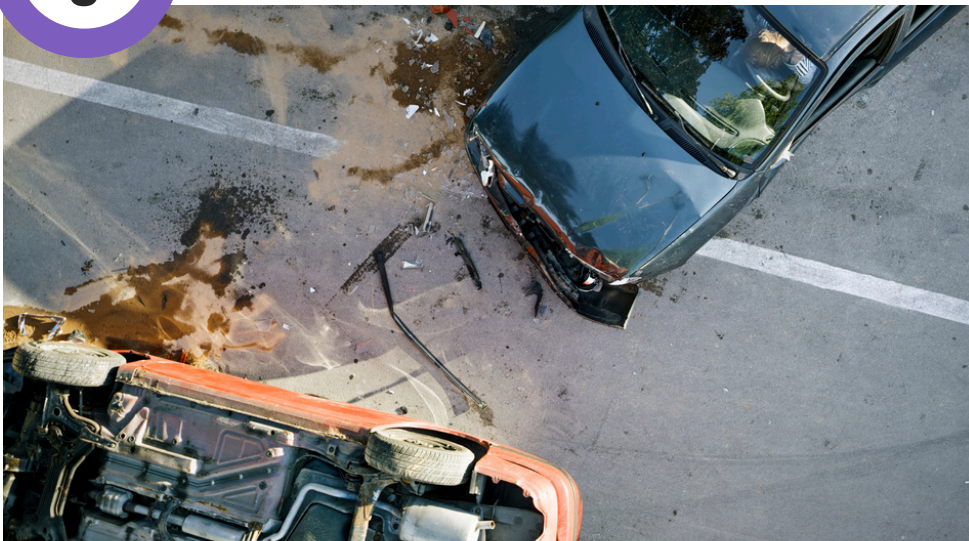

Even if your case is outside our scope, when you call BLF, our goal is to connect you with a lawyer we know and trust - someone who will handle your case with the same care we would.



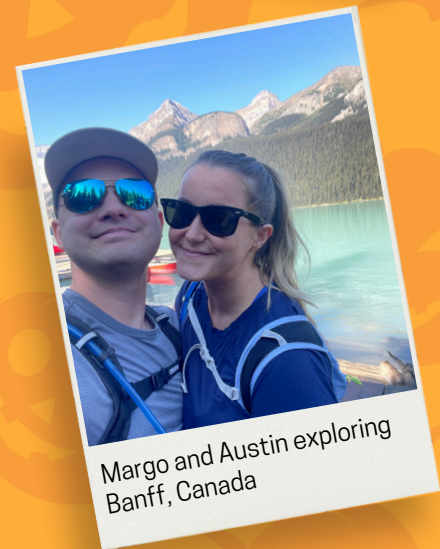
This case is a reminder that life can change in an instant, and the road to recovery is often complicated. With the right support and advocacy, it is possible to move forward even when it feels impossible.
