That sense of community also extends to Jennifer's life outside of work.




We're so excited to have Jennifer as a member of the BLF family.

WHEN NEGLIGENCE STRIKES A CHILD'S EPIPEN INJURY AT DAYCARE

In 2024, an incident at a Waxahachie daycare left a 4-year-old in need of emergency medical treatment after another child found an EpiPen in a backpack. The child, mistaking it for a "special marker," injected themselves, causing immediate harm and long-lasting emotional trauma for both them and their family.

The backpack containing the unsecured medication had been left within reach of the children. Despite being supervised by three teachers and an assistant director, no adult intervened before the EpiPen was used. Staff also failed to respond appropriately afterward. Emergency services weren't contacted until the child's mother arrived and had to instruct the panicked assistant director to call 9-1-1.

The child's mother was overwhelmed and unsure what to do next. She reached out to

our team for guidance. We helped her document everything—each conversation with the daycare, communications with staff, and any changes in her child's behavior. We also recommended that the child be seen by their pediatrician as soon as possible to monitor medical and emotional recovery. We ensured that Texas Health and Human Services (THHS) was notified and a formal report filed.

Our investigation revealed multiple violations of state childcare standards: medications must be stored securely, caregivers must supervise children properly, and staff must respond immediately in medical emergencies.

None of these standards were followed. The daycare's lack of oversight and inadequate training created a dangerous environment with real consequences.

Throughout the process, we worked with the family to make sure their story was heard.

We addressed the physical injury and the lasting emotional and psychological toll on both the child and the family. At every step, the family received support and guidance so

they never felt alone.

Ultimately, accountability our work provided and helped the family begin to rebuild their sense of safety and trust. Incidents like this are preventable, and when a daycare fails to protect a child, we step in to hold them responsible and help families move forward.
