MCKAYLA DISAPPEARED FROM DAYCARE!

Here's How We Helped Her Family

In the fall of 2021, Rebecca* opened her front door to a shocking sight: Her 3-year-old daughter, McKayla, was standing on the stoop surrounded by strangers. McKayla was supposed to be safe in daycare — so how did she end up at the front door?

The story is straight out of a parent's worst nightmare. As Rebecca learned later, her daughter had simply walked out the daycare's front door. The facility was understaffed, and the remaining workers couldn't access critical emergency contact information, so they didn't notify Rebecca or the police that McKayla was missing.

Meanwhile, McKayla wandered through town alone, scared, and confused.

Eventually, she ran *into the middle of a busy road* looking for help! McKayla could have been seriously injured, kidnapped, or even killed. Fortunately, a group of kind strangers stopped to help her find her way home.

The incident had a happy ending, but it still took a toll on McKayla's mental health and her family's daily routine. Doctors diagnosed McKayla with an adjustment disorder, and Rebecca — a single mom — had to leave the workforce to care for her.

After McKayla arrived home, Rebecca called the police to get to the bottom of her disappearance. She also reached out to our team for help and to hold the daycare accountable. When we investigated, we found that the facility had a long history of failing to properly supervise the children in its care, employing unqualified and untrained caregivers, and failing to meet the correct caregiver-to-child ratio and license capacity.

We presented our evidence and ultimately secured justice for McKayla! The result was an enormous relief for Rebecca and her family. Everyone in their situation deserves



that relief. To make it happen, our team will continue helping as many children and parents as we can!

HOT DAYCARE VANS CAN BE DEADLY

Follow These Steps to Protect Your Child!

Did you know more children die in hot cars and vans in Texas than in any other state? From 1990–2021, nearly 150 Texas kids were killed in hot vehicles, and some lost their lives in daycare vans.

How does this happen? Well, when a daycare van is parked in the sun, the temperature inside rises by 20 degrees every 10 minutes. That means on a 95-degree day, a van can reach 135 degrees in just 20 minutes! As a parent, it might seem impossible to prevent your child from getting heat stroke at daycare. But there are a few things you can do to ensure they aren't forgotten in a van.

ASK YOUR DAYCARE THESE QUESTIONS:

 What systems do you use to prevent children from getting heatstroke in your facility's vans? It's not enough for a daycare to count heads when children enter and leave a vehicle. They should use a documented roster check with roll call, require two different staff members to check the van after the kids get off, and lock the van when it's not in use.

 If your team finds a child in a hot van, at what point will they call 911?

A competent daycare should immediately call emergency services or drive the child to the hospital. Notifying the child's parent(s) should come directly after.

Has your staff received training on how to treat heatstroke in children?

Qualified caregivers should have this

training, just like they should have their CPR certificates.

LEARN TO SPOT THE DANGER SIGNS.

If your child comes home feeling nauseous, sluggish, disoriented, or thirsty, a daycare provider may have left them in the heat for too long. Other signs include a racing heart rate, a high temperature, and body cramps.


