An unannounced investigation inspection was conducted on 2/26/2018 I was greeted by the assistant director . I informed of the reason for my visit. All areas, both inside and outside were evaluated for obvious risk to children. The entire inside of the operation was walked. No obvious hazards were observed. During the walk through Care giver and had nine children ages 12-18 months Caregiver and had 11 children ages 18-24 months. Caregiver had 15 children 2 years old and e had 4 infants Caregivers and had 7 infants Caregiver had 12 children ages 2-3 years. had 8 children school age Caregiver Caregiver had 17 children all school age had 14 children ages 4-5 Caregiver and had 14 children ages 2-4 Caregiver I then walked the entire outside area and playground no obvious deficiencies were found. All unitary surfacing was in compliance. I then returned to the office discussed the details of the investigation with director and interviewed staff, all contacts are listed in investigation section.. The exit interview was conducted with (Director) The form 2936 was reviewed; I reviewed all findings and reviewed technical Assistance. I informed the director findings for investigation would be decided at a later date and are pending at this time.

informed me she was informed by a caregiver that the bus driver **weak** pushed a child in the back and told him to go and play. **Weak** said there were two caregivers on the playground who witnessed the incident but when she tried to look it up on the video camera she could not verify what happen. said she informed **weak** (Driver) she would investigate the incident and she was suspending her for a day without pay why she tried to investigate the allegation. **Weak** stated she did not report anything to licensing because she could not verify what happened. I informed **weak** that they are required to report suspected abuse or neglect to licensing. **Weak** stated she has had concerns with this caregiver before and parent have reported that the caregiver has a harsh tone and she has said some things that are inappropriate to the children.

Investigation Findings:

Disposition (if A/N):

Explanation of Disposition:

Based on information obtained from interviews with parents, caregivers and children it was determined a caregiver pushed a child forcefully as a means of discipline. Based on interviews with parents, and caregivers, it was determined various parents reported a caregiver to the director on several occasions for inappropriate discipline. Based on interviews with children, caregivers and parents it was determined a caregiver was

calling children humiliating names and speaking in a harsh manner.
